

- Our Apprenticeship program is registered with the US Department of Labor
- Wages are governed by registered standards with wage increases scheduled every six months.
- Apprenticeship duration is five years.
- Apprentices will be classified as Building Trades or Service
- Building trades attend one day every two weeks throughout the five years.
- Building Trades will obtain the following: Journey Plumber License, Medical Gas License, and Backflow Tester License.
- Service will obtain CFC license, electrical knowledge, and equipment service skills.
- Apprentices will be dispatched to contractors (employer) that are often temporary in nature, lay-off are common.
- Work conditions could be inside or outside, extreme conditions such as, Heat, cold, muddy, underground, high work, noisy, heavy lifting, or rainy.
- We graduate 90% of our apprentices and they go on to have long careers in the piping industry advancing on an individual basis, some become foreman, or superintendents, many work with the tools until retirement
